Update on Permit Use

Staff confirmed that TDSB is still proceeding with the gradual return of community use of schools. Swimming pools and the Before and After school programs have started and are running smoothly. Small issues/hurdles regarding scheduling or other items have been resolved. The Weekend indoor permits are scheduled to start on October 16, 2021 for gymnasium and other spaces.

Permit Staff will begin to look at scheduling weekday permits, subject to provincial, TPH and TDSB approval. There is a possibility of a weekday pilot program starting with City of Toronto Parks, Forestry and Recreation programs in a few schools. The pilot program will encompass weekday permits for 3 to 4 weeks, at various schools in under-served areas as identified by the City. The timeframe will allow TDSB staff to understand the amount of time needed to clean and set-up space between school-use and community-use, and then prepare the space for the start of school, the next day.

Cleaning and Permit Times

Staff noted that some schools have also started extra curricular activities which will intensify the use of gymnasiums. CUSCAC members asked about the amount of cleaning time required on weekends between permits. Staff responded that it is subject to what spaces are used within the building – for example, currently the planning is based on a two-hour timeframe for cleaning between permits and at the end permits prior to school on Saturday and Sunday. In some cases, the cleaning time could be reduced depending on the size and number of rooms used of by the permit.

Weekend use at this time includes Saturday and Sunday only, no decisions have been made about expanding weekend use to include Friday evenings.

For weekday permits, staff explained that to provide sufficient cleaning time between school and permit use, there could only be one permit group at a time, per evening. This would apply for schools that have both gymnasium and pool permits – only one permit per evening, in each area, for a total of two 4-hour permits per building.

Screening and Proof of Vaccination (POV) process

Staff have shared the Toronto Public Health and provincial health requirements to all permit holders, outlining the screening and proof of vaccination process. Anyone participating in a permit held in a TDSB facility, who is 12 years and older, including spectators, must be

fully vaccinated. Individual permit holders/organizations are required to set-up and manage these protocols for all participants, as well as follow TDSB protocols.

TDSB staff explained that permit holders are not required at this time to provide the list of participants, with confirmation of vaccination to the TDSB (Permit Unit). The responsibility of collecting and keeping the list of participants, for contact tracing and proof of vaccination is the responsibility of each permit holder/organization (for each permit). Permit holders should be prepared to provide this information upon request to provincial public health, TPH, Ministry of Labour inspectors, as well as the TDSB, if contacted by these agencies. Caretakers will not be collecting any information from the permit holder except validating the lifeguard certificate.

Local Neighbourhood Support Programs (LNSP)

No change since the September CUSCAC meeting. LSNP Community Permits could begin later in the fall or new year with the gradual start of weekday/evening permits. Currently, there are no weekend permits issued for LNSP.

Focus on Youth

There will be an update on the 2021 Focus on Youth (FOY) program at the November CUSCAC meeting. The Committee requested that there be regular representation and updates form Focus on Youth throughout the year – in the spring and the fall.

Other Updates:

Pools Working Group Update – Pools are in use and have found ways to comply with the physical distancing spacing requirements to offer swim programs.

Baseball Working Group Update - No Update.

Onboarding for New Committee Members – Co-Chair Gargaro has reviewed the CUSCAC Terms of Reference in preparation for on-boarding new committee members. In addition, there is a one-page document explaining the role of CUSCAC. The revised Terms of Reference will be sent by email to the committee members for final review. Any changes to the Terms of Reference will need to approved by the board, prior to posting on the TDSB website.

Virtual AGM – Virtual AGM was originally scheduled to happen on November 30th this year however as there are other committee meetings planned for that evening, CUSCAC committee considered and approved holding the virtual AGM on December 7th, 2021. A 30-day advance notice will be sent to those permit holders and organizations eligible to be on the committee.

Review of Committee Membership and Vacancies – There is a vacancy from retirement of one of the committee members, who represented the group, Citizen of Long Learning. Co-Chair Gargaro will reach out to Citizens of Life Long Learning, requesting another representative for CUSCAC.

Committee Goals for 2021-22 – CUSCAC heard from Co-Chair Aarts that the Board is in the process of reviewing advisories committees and the relationship of how the Board and Community Advisory Committees (CAC) interact. There are currently 12 advisory committees at TDSB. Arising from this review, there may be a formal request to each CAC, to develop and present their goals.

Trustee Update:

Co-Chair Aarts provided a detailed update on a variety of issues including the board's Vaccination Procedure as well as the following topics:

- The dates and registration link for Parents and Caregivers as Partners conference. Dates are October 16-17, 2021. This conference offers lot of workshops.
- Information regarding two reports that may of interest to CUSCAC. One report summarizes the 2021 summer school program, and the other report from Caring and Safe Schools provides information regarding types of programs in special education in different schools.
- Update regarding current TDSB enrolment (as of September 29) and financial implications.
- Update regarding voluntary Student vaccination disclosure and Staff Vaccination Status.
- Access to Rapid Testing kits.

Elementary Alternative Application and Admission Procedures Feasibility: Update

Recommendation

It is recommended that the report be received.

Context

At the May 5, 2021 Program and School Services Committee (PSSC) meeting, the Alternative Schools Community Advisory Committee (ASCAC) brought forth the following recommendations:

That the TDSB conducts a review of the application and admission procedures across all elementary alternative schools to ensure they are consistent and equitable.

Furthermore, ASCAC recommends that TDSB consider creating one universal elementary alternative schools' application form, as well as one set of clear and detailed admissions procedures for all elementary alternative schools to ensure consistency, equity and remove potential barriers. Ideally, this information will be clearly posted on the TDSB website to make it easily accessible to the schools and the general public for reference.

At the May 26, 2021 Board meeting, the Board decided:

(a) That the Director conduct a review of the application and admission procedure across all elementary alternative schools to ensure that they are consistent and equitable;

(b) That the following be referred to staff for a report on its feasibility in the fall 2021 cycle of meetings:

i) that the Director consider creating one universal elementary alternative schools application form, as well as one set of clear and detailed admissions procedures for all elementary alternative schools to ensure consistency, equity and remove potential barriers;

ii) That the application process be clearly posted on the TDSB website to make it easily accessible to the schools and the general public for reference

Action Plan and Associated Timeline

In accordance with Board motion (a), staff are in the process of reviewing the application and admission procedures of all elementary alternative schools to ensure that they are consistent and equitable.

Staff are currently collecting information about elementary alternative school admissions from schools and central staff. Based on the preliminary data, staff confirm that it is feasible to begin the process of creating a centralized elementary alternative schools' application form, as well as one set of clear and detailed admissions procedures for all elementary alternative schools to ensure consistency, equity and to remove potential barriers.

In May 2021, the Elementary Alternative Application and Admission Procedures Working Group (Working Group) was formed.

In June 2021, the Working Group met with the administrators and Superintendents of the elementary alternative schools about the Board Motion and to discuss the current application process in each school. In addition, the Working Group consulted with IT Services staff about technological support for an online application process.

In the upcoming months, the Working Group will meet regularly with elementary alternative schools and members of ASCAC, have consultation sessions with representatives from the Board's Community Advisory Committees, and seek guidance from Equity, Indigenous Education, Human Rights, and Legal Services staff.

Resource Implications

The Working Group will work with IT Services and Research Department to access their expertise and resources in developing a consultation framework and an online application form that meets all the requisites gathered from the consultations.

Communications Considerations

The Working Group will work with the Communications Department to develop a communications plan upon completion of the centralized admissions process.

Written Notice of Motion as Emergency Business (Trustees Tonks and Nunziata)

From: Denise Joseph-Dowers, Manager, Board Services, Governance and Board Services

In accordance with the Board's bylaws, emergency business is defined as:

a situation, or the threat of a situation, adversely affecting health, safety and/or wellbeing, or resulting in significant legal risk or financial damage or loss, which by its nature and seriousness requires an immediate response...

Further,

5.12.7 A matter not on the agenda or directly related to matters arising from discussion cannot be introduced by a trustee at a Board or Committee meeting, or after the notice of agenda has been circulated to members, unless the item qualifies as emergency business and is confirmed by a two-thirds majority vote of the members present.

Supporting Free Public Transit for High School Students

Trustees Tonks and Nunziata have submitted the following as a matter of urgency and for consideration as emergency business.

Therefore, be it resolved:

A. That the following matter be deemed as emergency business;

and, if approved (requires a two-thirds majority vote of the members present to be considered);

B. That the following be considered:

Whereas, the Toronto Transit Commission is seeking feedback from stakeholders as it creates a 5-Year Fare Policy and 10-Year Fare Collection Outlook and will present an initial proposal on November 17, 2021 and hold a final vote in February 2022; and

Whereas, using transit at a younger age can encourage life-long use of transit, influencing behavioural change for a more sustainable future (Lachappelle et al, 2016); and

Whereas, a program in Kingston, Ontario to provide free transit passes to high school students, along with an on-bus orientation session to teach students how to ride the bus, has increased overall transit ridership by 73% since 2012 (Federation of Canadian Municipalities, 2019); and

Whereas, students and teachers have reported a reduction in low-income students' enrolment in specialized programs, after financial constraints resulted in the end of a TDSB program to provide free TTC tickets to Grade 9-12 students taking French

Immersion, Extended French, and Gifted programs in 2019 and to elementary Grade 6-8 students taking Gifted and French Immersion programs in 2020; and

Whereas, the TTC is free to ride for children 12 years and younger, but many young people do not have or carry identification and high school students reported in focus groups (TTCriders, 2021) that as younger teenagers they experienced discrimination from fare enforcement based on race and age, and were challenged about their age;

Therefore, be it resolved:

- (a) That the Toronto District School Board express support for an expansion of free public transit to high school students;
- (b) That the Chair write to the Toronto Transit Commission Board by November 17, 2021, recommending that they expand free TTC rides to high school students as they develop their 5-Year Fare Policy and 10-Year Fare Collection Outlook;
- (c) That the Chair write to the Mayor of Toronto, Ontario Minister of Transportation and Transport Canada to advocate for funding support for the Toronto Transit Commission in order to implement free transit for high school students;
- (d) That a copy of the letters in parts (b) and (c) be shared with the Ontario Public School Boards' Association.
