#### Subject Toronto Lands Corporation (TLC) Performance Review

**Purpose** A third party performance review of the Toronto Lands Corporation will be undertaken to enable TDSB staff and Board of Trustees to conduct a performance evaluation of TLC. The review will include, but is not limited to, assessing whether the current governance/corporate structure, mandate, and delivery of services meets TDSB's objectives and responsibility for effective stewardship of its real estate and land use planning portfolio. The consultant(s) review will include recommendations in relation to the findings to address service improvement and risk mitigation strategies.

The consultant(s) will be expected to engage key stakeholders including TDSB staff, TDSB Trustees, TLC staff, and TLC Board of Directors to gather information and prepare a report that will identify and evaluate TLC's strengths, successes, and challenges in light of their expanded mandate, and make recommendations on what changes, if any, are necessary to meet TDSB's objectives.
